The Confederate records show that Hendley Snow (name also borne as Henly and as Henley Snow), private, Company E, 9th Reg't Georgia Infantry, C.S.A., enlisted March 4, 1862, at Dalton, Ga. On the muster roll for March and April, 1864, last on which borne, he is shown to have deserted July 3, 1863.

The Union prisoner of war records show that Snow was captured July 3, 1863, at Gettysburg, Pa., and that he was sent to Ft. Delaware, Del., where he was enrolled in Company G, 3d Maryland Cavalry, U.S.A., September 18, 1863.
